STUDY Customer Satisfaction Survey Results FY 2022 ITEMS

Frost Research Center at Hope College was contracted by HBPW to conduct a survey of business and residential customers regarding satisfaction with various aspects of their utility service and relationship with HBPW. The survey includes a dashboard which provides aggregated and disaggregated customer responses to each question in an interactive format. The survey resulted in overall satisfaction ratings achieved of 90% better than neutral for residential customers and 96.5% better than neutral for business customers.

A number of written comments were also received, and where requested, we followed up with survey respondents on any questions they had about a particular topic.

In addition, we are putting together a customer communication addressing some common questions received through the survey, including rate competitiveness, the elective renewable energy rate, broadband availability and readiness to serve charges.

22.218 Insurance Update

Marsh USA was appointed the insurance agent of record for the City and HBPW on February 16, 2022, for all property and liability insurance needs, excluding the property coverage for HBPW power production assets. Marsh USA was appointed as insurance agent of record for the HBPW power production property coverage on June 8, 2020.

Firm quotes have been received from three out of the five carriers providing coverage under the HBPW property program. The premiums quoted are ranging from 5-6% higher than the FY 2022

program. Overall cost for the property coverage is not expected to increase by the same rate, since Unit 6 coverage will be removed from the program.

For the combined program, firm quotes have been received for work comp and public officials liability. The work comp premium declined by approximately 1%. The combined property/liability (Brit) package premium is expected to increase about 10%, based on conversations with the carrier. Premiums for the other packages (excess property, excess liability, boiler and machinery, and automobile) are expected to see premium increases in the 5% range. Cyber liability, difficult to place last year, is even more difficult this year; and no premium indications have been received, yet.

Marsh expects final numbers by the end of this month and will be ready to present the complete programs to HBPW on June 6 and the City on June 15.

22.219 Discussion Regarding the Appropriateness of HBPW Results Policies and Key Performance Indicator (KPI) Targets

Please recall that within the policy governance model, results policies are intended to represent the Board's expression of expected impact the work of the organization should have on its constituencies. As these statements are often more subjective in nature, KPIs were adopted by the Board to help put quantifiable measurements in place to assist with being able to judge the results policy statements.

The 2020 Strategic Plan, which contains the nested results policy statements and Key Performance Indicator descriptions, has been attached for reference.
