### Step #1: Make Sure Your Project is Eligible

Check the specifications listed in this application, and/or speak with Holland BPW Conservation Programs Specialist by calling (616) 355-1534, to make sure your project is eligible for Energy Smart incentives. All equipment must be new and installed or operated in a residential dwelling where electric service is provided by the Holland Board of Public Works.

### Step #2: Complete Your Project

Install your new, energy-efficient equipment following the specifications listed on page 4 of this application.

### Step #3: Apply for Your Rebate

Once your project is complete, it's time to request your rebate.

### **Submit:**

- 1. A completed and signed Customer Information sheet, page two, and Incentive Worksheet, page three
- 2. A copy of the receipts indicating make, model, and payment in full
- 3. Itemized invoice(s) for contractor-installed equipment, including installation date, costs for equipment installed and installation labor
- 4. Proof of ENERGY STAR® (can be photos or specification sheets) for all appliances and other equipment
- 5. The AHRI certificate for furnace, mini-split heat pump, and central air conditioning units

Your completed application and the required documents listed above must be received by December 31, 2020.

Limited funds are available. Please allow 4-6 weeks to receive your Energy Smart rebate from the time your completed application is received.

\*Exceptions include smart surge protectors and thermostats

## 2020 Energy Smart Residential Program Equipment Specifications & Documentation Requirements

### **Equipment Specifications & Documentation Requirements**

#### **GENERAL PROGRAM RULES**

This offer is valid only for Holland Board of Public Works residential electric customers for a limited time. Offer is good while funds are available, on a first-come, first-served basis. Program begins January 1, 2020, and **application must be received within 90 days of purchase and/or installation of measures on December 31, 2020, whichever is earlier**. Holland Board of Public Works reserves the right to withdraw or change this offer without notice. **Incentives may not exceed purchase price.** Ineligible incentive requests are subject to denial or repayment to program. Incentive requests must be received by December 31, 2020. Call (616) 355-1534 for more information.

#### **EQUIPMENT SPECIFICATIONS**

Central Air Conditioning: AHRI Certificate required to verify efficiency. SEER 15, 16, or 17.

Mini/multi-split heat pump: AHRI Certificate required to verify efficiency. Make and model numbers for indoor and outdoor units required. SEER 18+.

**Furnace:** AFUE ≥ 95%. Air handlers must have Electronically Commutated Motor (ECM) to be eligible for the incentive. AHRI Certificate required to verify efficiency.

ENERGY STAR® Room/Window AC Unit, Dehumidifier, Refrigerator, Freezer, LED Bulb, TV, Air Purifier, Monitor and Personal Computer Products:

To verify purchase, please send in a copy of the receipt with the product model numbers on it. Additionally, provide proof of ENERGY STAR® certification. Limit of 40 LED bulb rebates per customer per year.

**ENERGY STAR Heat Pump Water Heater and ENERGY STAR Pool Pump:** To verify purchase, please send in a copy of the invoice with the installation date, receipt with the indoor and outdoor product model numbers on it, and specification sheets.

ENERGY STAR Electric Clothes Dryer: Must replace a standard efficiency electric clothes dryer. New unit must be ENERGY STAR® certified.

**Smart Strip Plug Outlet:** Does not require ENERGY STAR qualification. The Smart Strip Plug Outlet must be new and have one or more outlets that have integrated automatic (controlled) shut-off, when connected equipment is not being used (automatic control used to save energy). A copy of the receipt from the store where the Smart Strip Plug Outlet was purchased is required. Limit 4 rebates per customer per year.
