Labor Agreement with UWUA Tabled to Special Meeting of March 27, 2018

A detailed summary of the proposed labor agreement is attached to this recommendation. The summary includes background information regarding the labor agreement renewal process as well as a comprehensive summary of proposed changes to the expiring labor agreement.

HBPW management believes that the proposed labor agreement represents a fair and appropriate continuation of the professional business relationship the utility has cultivated with the union. The proposed agreement addresses the compensation and benefit issues. The agreement also continues to provide and protect the rights of management to direct and make changes to its workforce as deemed necessary to continue its high levels of customer service and reliability.

The entire labor agreement is attached and has been reviewed as to form by legal counsel.

Recommendation: The Board of Directors approved the attached labor agreement between the HBPW and UWUA effective April 1, 2018, through March 31, 2021, then forward to City Council for their approval.

18.142 Water Transmission Redundancy

The 36" diameter prestressed concrete pipeline built in conjunction with the Water Treatment Plant in 1955 is a critical asset carrying 75-80% of the total water demand for the Holland BPW system. A break on any point along an 18,000 foot section of pipe will limit water transmission capacity below average day demands.

The pipeline was inspected in 2017, and several valve replacement projects are planned for the shorter term. Several options for building additional pipeline between 160th and 144th Avenues in Park Township are being considered to build redundancy across the most critical section of the pipeline. The current five-year budget allocates \$6.75 million for improvements to the pipeline.

18.143 **2017 Energy Waste Reduction Program Results and Review**

The State of Michigan passed the Clean, Renewable, and Efficient Energy Act (Public Act 295) late 2008. The overall goal of the energy optimization (EO) portion of the law, now called Energy Waste Reduction (EWR), is to reduce future costs of provider service to customers. EWR plans are to include program offerings for each customer class and are reported to the Michigan Public Service Commission on a calendar year basis. This is a review of the HBPW 2017 Energy Smart program initiatives and results and an overview of the plans and metrics underway for 2018.
