STUDY TOPICS

Energy Risk Management (ERM) Performance Summary

As detailed in the attached report, under the ERM program, HBPW has natural gas purchase agreements in place for a total of 10,010,360 decatherms, at weighted average costs (sans basis) per decatherm ranging from \$2.38 to \$2.48 for fiscal years 2021-2025. The total cost of the agreements, when exercised, will be \$24,256,821 over the five year period. The total cost of these agreements is approximately \$2,167,250 less than current market prices (at March 31, 2021) for the same quantities and periods.

Including energy resources under contract through MPPA, and the natural gas purchase agreements described above, HBPW has hedges in place as a percentage of planned MWh dispatch as follows:

- FY2021 87.0%
- FY2022 91.0%
- FY2023 77.4%
- FY2024 57.3%
- FY2025 46.4%

The natural gas hedges (purchase agreements) in place, as a percentage of planned natural gas burn, are:

- FY2021 79.0%
- FY2022 84.2%
- FY2023 62.8%
- FY2024 31.6%
- FY2025 10.9%

No new natural gas purchase agreements have been entered into this quarter. A structured objective approach for entering into natural gas hedges is required by the ERM Policy. No value or time-based triggers were met during the quarter ended March 31, 2021.

21.214 Customer Satisfaction Survey Results FY 2021

Frost Research Center at Hope College was contracted by HBPW in January 2021 to conduct a survey of business and residential customers regarding satisfaction with various aspects of their utility service and relationship with HBPW. The survey this year includes an additional dashboard which provides aggregated and disaggregated customer responses to each question in an interactive format. The survey resulted in overall satisfaction ratings achieved of 91.1% better than neutral for residential customers and 94.9% better than neutral for business customers. The presentation was given by Julie Ornee from the Frost Research Center.
