



Holland Board of Public Works Residential Rebate Application 2026

1. Confirm Eligibility

- You are a Holland BPW electric residential customer.
- Your purchase, project, or product meets the conditions for a rebate and was purchased new or completed between January 1 - December 31, 2026.

Are you a City of Holland resident? If you are and you have also completed the *Home Energy 101* program, you're eligible for additional Holland Energy Fund rebates! (pg 6)

2. Fill Out and Submit Rebate Application

- Fill out this form and sign it (pg 4). Printed or electronic signatures are accepted.
- Complete the rebate worksheet on page 5.
- Gather your documentation (see pg 3).
- Submit it!

All rebates require more documentation than just this application. Each rebate must include invoices/receipts. These receipts must indicate the make, model, payment in full and date of purchase for each rebated item. Some items require additional documents such as an AHRI certificate, proof of ENERGY STAR certification, or an electrical permit.

You can submit these digitally, by mail or drop off - the same way you would submit your application. Copies of documents are accepted.

3. Get Money for Saving Energy

Once we receive your application, it will take about 4-6 weeks for your rebate to be processed. Rebates \$100 or less are automatically added to your account as a credit. If your rebate is above \$100, you'll be asked in this application if you would prefer a credit or mailed check.

Holland BPW Rebates

AC or Heat Pump Tune Up

A tune up is a cleaning and inspection of the indoor and outdoor coil, which includes cleaning or replacement of air filter, inspection and lubrication of blower, cleaning/inspection and lubrication of motors, checking/adjusting the refrigerant, confirmation of proper airflow, checking condensate drain, cleaning debris from and around the condenser, and performing visual inspection of entire system. AC tune-up limit 1 per customer per year. Heat pump tune-up limit 1 per cooling season and 1 per heating season per customer per year.

Heat Pumps (pre-approval recommended)

Heat pumps must be the primary method of heating and cooling. Both the indoor and outdoor models must be listed on the invoice, installed at the same time, and AHRI rated together. Mini-split tonnage is determined by the size of condenser (outdoor) units, not number of cassettes. Self-installed units are eligible for rebates up to the purchase price of materials and require a finalized permit from the City/ township.

Heat Pump HVAC rebates are available for residential dwelling spaces only. Non-eligible spaces include spaces that are not used as a dwelling space, such as a garage, hobby space, or outbuilding. ADUs may qualify if they meet the following: a) occupied full-time b) include a full bathroom and fully functioning kitchen c) separate ventilation from the primary dwelling.

There are 2 types of rebates for heat pumps, depending on any additional heat sources in the home. 1) Homes with heat pumps as the sole source of heating and cooling may apply for the all-electric home heating rebate. New or existing back-up heat sources must be electric. 2) Homes with new or existing non-electric heat sources such as gas furnaces may apply for the dual-fuel rebate, provided the heat pump system is the primary method of heating and cooling the space.

Electric Lawn Tools

Holland BPW electric customers must purchase a qualifying electric lawn tool to receive the rebate. Electric tools may be battery-powered or plug-in. Limit one rebate (tool-only or tool-plus-recycle-bonus) for each type of electric tool per year. Any customer seeking the recycled tool rebate in addition to the electric tool rebate for a given tool must recycle an existing gas-powered tool of the

same type (e.g. mower). To do so, drain the gas-powered lawn tool of all fluids and bring it to PADNOS Black River Recycling Center located at 11531 Chicago Drive, Holland, MI 49424. Ask for a Holland BPW recycling receipt. Residential customers must own the units being recycled.

Electric Panel Upgrades

Upsize an existing service panel capacity to a minimum 200 amp service or install a UL-listed and hard-wired load management device for a specific circuit. This must include the addition of a Level 2 EV charger or at least one 240V appliance electrification (converted from natural gas). A licensed electrician must complete the work. You will have 12 months from the panel upgrade to install qualifying equipment to receive the rebate.

Central Air Conditioning

For AC units, the indoor coil and outdoor condenser must be a matched set and installed on the same date to be eligible. AHRI certificate must match model numbers on invoice.

EV Charging

Level 2 charger invoice and copy of electric vehicle registration are required on submission. Vehicle registration and HBPW account must have the same address. Customers who receive a rebate will have their whole house placed on the EV Time-of-Use rate for a minimum of one year. Declining the Time-of-Use rate forfeits the rebate. Go to the HBPW website to review the rate to make sure this rate fits your charging habits. Visit hollandbpw.com/en/electric-vehicles.

By enrolling in the EV Charger Program, the Participant accepts the following terms and conditions as outlined or as may be amended:

1. Program Participants shall agree to participate in the HBPW's Electric Vehicle Whole House Time-of-Use rate as a requirement of the rebate. Further details about this rate are contained in the HBPW Rate Book.
2. The actual cost of the charger must be itemized on a paid invoice, installation contract, or purchase agreements. The

rebate shall not exceed the combined cost of the EV charger, professional installation (if applicable), and permit. Participants are limited to one EV charger rebate per vehicle, per HBPW residence.

3. The qualifying Level 2 (240V) EV charger must be: new and unused, certified by Underwriters Laboratories Inc. (UL Listed) OR ETL Listed. The EV charger must be wall-mounted. Portable chargers do not qualify unless a 240V circuit was added within one year of the time of purchase of the portable charger solely for the purpose of the portable charger. If a 240V circuit is added (to a garage for example) to accommodate a Level 2, 240V charger that is portable, then the charger qualifies for a rebate. If the household service is upgraded to 200 amps, see details above for a panel upgrade rebate.
4. Program Participants must be in compliance with all federal, state, county, and city government regulations regarding the installation of EV Chargers, metering equipment, or any other support equipment required or necessary for the proper and safe installation of an EV Charger. In

addition, the Program Participant has the sole responsibility of securing all necessary and required permissions from the property owner, homeowner association, or any other organization from which permission to make such installations would be required.

5. The EV charger shall remain in service at the installation location indicated on the rebate application for a minimum of one year unless the HBPW electric service account is closed during the designated timeframe. Failure to adhere to the one-year service requirement may result in the forfeiture of all paid rebates, or a portion thereof, as determined by the HBPW.
6. HBPW may utilize, without compensation, the data generated by the use of the EV charger to improve HBPW services, conduct studies, or for any other purpose in furtherance of HBPW operations. Such data may also be provided to other entities for research and grant purposes and/or as required by law.

Required Documents

All applications must include the following:

- Invoice/receipts indicating the make, model, payment in full and date of purchase for each item receiving a rebate.** Copies of documents, along with this completed and signed application, can be emailed to energysmarthome@hollandbpw.com, or mailed/dropped off to the Service Center at 625 Hastings Ave.
- AHRI certificate (central AC, air source heat pump)
- Contractor checklist and invoice (AC or heat pump tune up)
- Proof of Energy STAR certification (dishwasher, fridge, clothes washer, clothes dryer, air purifier, spa/pool pump, heat pump water heater, dehumidifier)
- Tool recycling receipt (for recycled gas leaf blower, lawn mower, snowblower, string trimmer)
- Electrical permit & proof of charger/appliance purchase (panel upsize or load management device)
- Photocopy of EV Vehicle Registration - address must match account holder address (EV charger)

General Program Rules

This offer is valid only for a limited time for Holland Board of Public Works residential electric customers. Offer is good while funds are available on a first-come, first-served basis.

The program runs January 1st – December 31st, 2026. Applications and required documentation must be submitted by December 31st of the year of purchase, or within 60 days of the purchase, whichever is later. Holland Board of Public Works reserves the right to withdraw or change the offer without notice. Rebates will not exceed the purchase price. Ineligible rebate requests are subject to denial or repayment to the program. All equipment must be new and installed or operated in a residential dwelling where electric service is provided by Holland Board of Public Works. Equipment purchased used, rebuilt/refurbished or open box are not eligible. An original receipt/invoice showing the date of purchase, purchase price, make/model information, and payment in full is required.

HBPW makes no warranties and is not responsible for any representations, whether expressed or implied, including but not limited to, any warranty of merchantability, fitness for a particular use product performance and useful life, or application of the item(s) or measure(s) by manufacturers, dealers, contractors, or any other third parties, materials, workmanship, the quality, safety and/or installation of the item(s) or measure(s), effects on pollutants or any other matter with respect to the Program. General Holland Energy Fund Program Rules

Holland Energy Fund (HEF) rebates are only available to City of Holland residents who have completed the Home Energy 101 program. Offer is good while funds are available, on a first-come, first-served basis. Program begins January 1, 2026. Your completed application and the required documents must be received by December 31, 2026, or within 60 days of purchase/invoice, whichever is later. Holland Energy Fund reserves the right to withdraw or change this offer without notice.

Holland Energy Fund rebates may be combined with applicable Holland BPW Energy Smart rebates but will not exceed the purchase price of any given efficiency measure. For questions about HEF rebates, contact the City of Holland at 616-355-1355. Total cost of measure includes labor and material costs if installed by a licensed contractor. If you self-install the measure, you can only receive a rebate on the purchase price of the materials. Ineligible rebate requests are subject to denial or repayment to the Holland Energy Fund. All equipment must be new and installed or operated in a residential dwelling within the City of Holland. The City of Holland reserves the right to perform an inspection of the installation. Holland Energy Fund rebate total cannot exceed \$6,000.

Heat Pumps

Heat pumps must be the primary method of heating and cooling. Both the indoor and outdoor models must be listed on the invoice, installed at the same time, and AHRI rated

together. Mini-split tonnage is determined by the size of condenser (outdoor) units, not number of cassettes. Self-installed units are eligible for rebates up to the purchase price of materials and require a finalized permit from the City/township.

Heat Pump HVAC rebates are available for residential dwelling spaces only. Non-eligible spaces include spaces that are not used as a dwelling space, such as a garage, hobby space, or outbuilding. *Other Measures

Any air sealing project that is installed for the purpose of reducing air leaks in the applicant's home (not including new windows, storm windows, or other window inserts) may qualify. Any insulation project that is installed for the purpose of adding insulation of the exterior building envelope of the applicant's home (basement, exterior walls, and/or attic) may qualify. Insulation rebates do not apply to new construction.

Holland Energy Fund rebates are issued as a check separately from Holland BPW rebates. Please allow 6-8 weeks processing and mailing to receive your Holland Energy Fund rebate.
