- HBPW will send an invoice after equipment has been picked up. Invoice shall include a minimum of one week rental rate and consumption. Payment is expected within 30 days.
- All customers shall use APPROVED backflow prevention when renting 2 1/2" hydrant meters. If providing your own equipment, certified test results from within the last year will be required prior to equipment delivery.
- Water passing through this equipment is NOT SAFE FOR DRINKING.
- Hydrants shall be fully opened and controlled with meter valve.
